Private Well Water Nitrate Screening Form

As of January 1, 2016, the Illinois Department of Public Health State Laboratory is no longer conducting nitrate analyses on water supplies. Because nitrates and nitrites are not a widespread problem in Illinois, the state laboratories have shifted their resources to other needed services. This decision was made by the state and is out of the control of local health departments.

The Hancock County Health Department (HCHD) will screen for nitrates and nitrites in private well water. The screening will provide a very basic analysis to determine nitrate levels in residential well water. However, the Hancock County Health Department does not have a certified laboratory, therefore, any screening results will be considered UNOFFICIAL and cannot be used for legal purposes.

This service would not be appropriate for home daycares or non-community water supplies. See the list of certified labs on the back side of this page.

The Hancock County Health Department (HCHD) will provide UNOFFICIAL screenings for nitrates in water samples on Monday-Wednesday of each week. The bottle must be filled the same day that it is hand-delivered to the Hancock County Health Department. Bottles must be submitted before 1:00PM to allow appropriate time for analysis.

To have analysis completed by the Hancock County Health Department:

- 1. Complete and sign this form
 - 2. Fill the bottle provided by the Hancock County Health Department
 - 3. Place form and filled bottle in provided box
 - 4. Return the bottle and form between 8am-1:00pm Monday-Wednesday to:
